This exclusive offer is available to GMB members with at least 53 weeks continuous membership.

History & Background Information

On 1st August 2016 we launched the GMB National Lifelong Learning Fund, which is available to members to help them access education and training. The fund was launched to coincide with the first meeting of the GMB National Lifelong Learning Committee, which was created in line with Congress Motion 74 in 2015. Any member who meets the requirements can apply for financial assistance in pursue of education and training.

This membership benefit is viewed as both an organising and retention tool. As a retention tool, it is aimed at members who may have recently lost their employment and need financial assistance to assist them to up-skill and reskill.

Terms & Conditions

GMB members can apply by completing the National Lifelong Learning Fund application form for financial assistance towards any course that they have enrolled on, or would like to enroll on, to help them to achieve a qualification or skill which will enable them to improve their present and future employment and career opportunities.

Successful applicants cannot re-apply to the fund for a period of 12 months from receipt of their last grant from the fund.

Application Criteria

- The applicant must have been a fully paid-up member, on either the full-time, part-time, sick/unemployed or any other type of membership rate for more than 53 weeks.
- Successful applicants will be expected to retain their membership throughout the whole process once funding has been received.
- Applications should be made prior to the commencement of a course of study, or during the application stage when the individual knows they are eligible to undertake the course.
- You must attend a Branch Meeting and present the application form at your Branch Meeting, where sections of the form need to be filled in. This is also where you request if the Branch will also be able to assist with funding.
- Once the form has been completed and endorsed by the Branch, it must then be signed by the Regional Education Officer (REO).
- The Regional Education Officer then forwards the completed application form to the Chair of the National Lifelong Learning Committee via email.
- No commitments should be entered into on the assumption that an award will be made.
- The awards do not apply to any other College, institution or training provider.
- There is an appeal process which is stated on the form, any appeal must be sent to the Chair on the email below.
