Issue to be raised by letter, draft "Our members have drawn to our attention a concerning situation relating to the current policy on when London Weighting is payable. It seems to us that there is no definitive policy and that any policy that is used is applied in an arbitrary fashion. A quick Google search shows that the Civil Service London weighting was paid to civil servants whose permanent place of work was within five miles of Charing Cross (Inner London Weighting) and between five and 18 miles from Charing Cross (Outer London) and we believe that approach has been improperly employed for Judges by some members of Judicial HR. On other occasions, a paper document has been referred to and provided, which lists a number of venues that attract London weighting, but also refers to a secondary

list held elsewhere outside of that policy. The result is that there appears to be no fair, consistent and accessible policy on this matter. We would be grateful to hear your comments on this and would expect to be consulted in the drafting of a fresh, reliable and fair policy."
